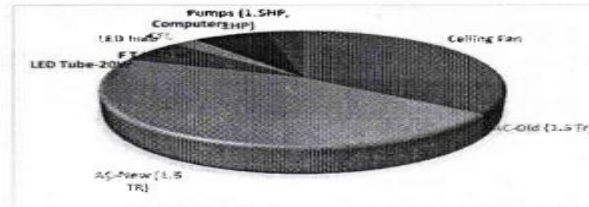


Figure 2.1: Distribution of connected load.

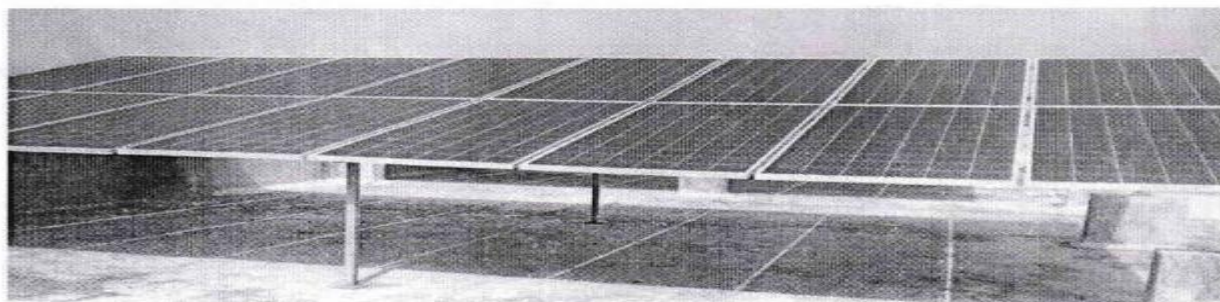

2. Management of Various Type of Degradable and Non Degradable Waste

Degradable and Non-degradable Waste Management

Effective waste management is a difficult task for any educational institution because it impacts the health of workers, students, teachers and the environment. Therefore, providing a healthy and safe environment is of utmost priority to the college. The college facilitates several techniques for the management of degradable and non-degradable waste. The primary focus is to reduce, reuse and recycle the waste. The DRGCOP has also advised us to reuse anything which is not needed. The college has different dustbins to segregate waste like gradable dry waste, wet waste etc. Every day the waste is collected in bins and disposed to a place where it can be converted into manure.


For *solid waste management*, different dustbins like blue colour dust bin for dry waste and green colour dust bin for wet waste are put in proper ways located in every floor of the institute and various position in college campus. This ensures that wet solid waste is segregated at the source. The college dug a compost pits for the disposal of biodegradable waste include food waste, canteen waste, paper waste etc. has been kept in a compost pit. Biodegradable, organic waste like cooked food, vegetables, fruits, and leaves are separated by the housekeepers while collecting garbage. The compost form in pit is used for the college garden, botanical garden and other trees and plants on the college campus.

Non-degradable solid waste like paper, cans, cartons, metallic items glass, blades, plastics, and band bandages are also separated and regularly given to the Grampanchayat waste vehicle locally called *Ghanta Gadi* which has regularly collected waste in college campus.

For Liquid waste management, all drinking water tank, laboratory basins, washrooms liquid outlets are collected separately in tank and the well and all sewage and liquid waste are used for irrigation, landscaping and gardening which is best part for utilization and water conservation by reusing liquid waste in campus. And scrap for e-waste like computer parts, cables, destock, are separately stock for e-waste management

As green campus initiation minimum use of paper policy is applied in the college, which helps conserve resources, and only a small amount of paper is wasted. Along with this instead of paper documentation utilized software (Biyani software) in Administration, store, and library.

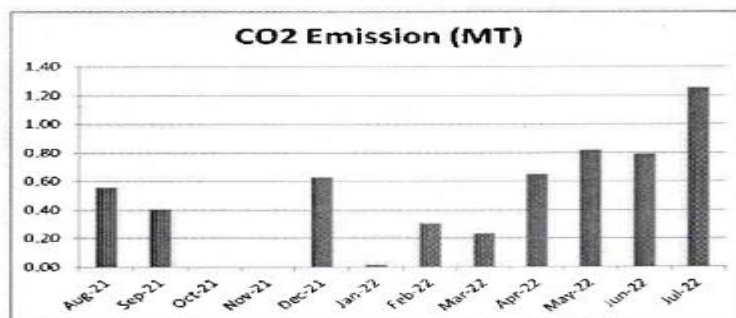


Figure 3.1: CO₂ emission due to usage of electrical energy.
